

# **FXTM 2022 WINTER OLYMPIC PROMOTION**

富拓2022冬奥活动 TERMS & CONDITIONS 条款和条件



#### 1. INTRODUCTION

引言

1.1. FXTM<sup>1</sup> is running the 2022 Winter Olympic Promotion (the "**Promotion**") which is applicable to selected clients at FXTM's discretion, including clients assigned under IB & Affiliates. By participating in this Promotion, you agree to be bound by the Terms and Conditions herein (hereinafter referred to as the "**Terms**") as these are set out below.

本2022冬奥活动(以下简称"**活动**")适用于由FXTM富拓决定的特选客户(代理商及网络联盟商名下的客户适用)。参加本次活动即表示您同意受以下条款和条件的约束(下简称"**条** 款")。

1.2. This Promotion Period shall run from the 24<sup>th</sup> January 2022 (00:01) to the 20<sup>th</sup> February 2022 (23:59) (Beijing time) inclusive (the "**Promotion Period**").

活动期由北京时间2022年1月24日0点01分开始至2月20日23点59分止(以下简称"**活动** 期")。

1.3. A client who participates in this Promotion shall receive the "**Cash Bonus**" as defined in accordance with clause 4 of this Promotion and subject to the Terms herein.

参加本次活动的客户有机会获得根据本次活动条款4及其他条款和条件所规定的"赠金"。

#### 2. ELIGIBLE CRITERIA

## 资格标准

- **2.1.** To participate in this Promotion, you must meet the following requirements: 为参加本次活动, 您须满足以下条件:
  - a) You are a new or an existing client of FXTM, deposited during the Promotion Period or dormant client of FXTM, eligible to trade in accordance with, and have agreed to, the operative agreements;

您是富拓新的或现有客户,在活动期间入金,或是有资格根据有效协议进行交易的FXTM 的不活跃客户;

b) All clients that wish to participate in this Promotion must follow FXTM's official WeChat service account, bind their MyFXTM account with it before 20<sup>th</sup> February 2022, and reply "2022 Winter Olympic" in the WeChat service account before 20<sup>th</sup> February 2022. If you

have been bound to FXTM WeChat service account previously, you only need to reply "2022 Winter Olympic" in the WeChat service account to participate, and not need to rebind to FXTM WeChat service account.

所有想要参加本次活动的客户必须于2022年2月20日之前关注富拓官方微信服务号(微信 名:富拓集团中文服务),并将您MyFXTM账号和微信绑定,同时于2022年2月20日之前 须在富拓官方微信服务号中回复"领取冬奥红包"方可参加活动。现有客户,如此前已绑 定,则无需再绑,只需继续关注官方微信并直接在富拓官方微信中回复"领取冬奥红包" 即可。

c) Run a live trading account with FXTM as per the applicable deposit and/or other requirements of FXTM<sup>2</sup>

d) Read and accept the Terms of this Promotion;

e) Make a deposit in the Account during the Promotion Period, following c) and d) above.

2.2 The Promotion shall only be available to each client at the discretion of FXTM to offer the cash bonus and shall be given to the client after receipt of the client's Acceptance of these Terms.

2.3 Acceptance of these Terms must be express, in writing, and communicated from the client to FXTM via FXTM WeChat Service Account by replying "2022 Winter Olympic". (the "Acceptance").

#### **3 TRADING TERMS**

# 交易条款

3.1 The Promotion is applicable to all account types (Micro, Advantage and Advantage Plus).

Each client is to receive the cash bonus only once during the Promotion Period.

每位客户在本次活动期间仅能获得一次赠金。

3.2 Irrespective of the number of trading accounts that may be opened by a new and approved client with FXTM, the Benefit shall only be applicable to the client's trading account approved by FXTM (the "**Account**").

不论FXTM富拓的新老客户开设了多少个交易账户,本活动仅适用于获得富拓批准的客户交易账户(以下简称"**账户**")。

#### **4** SPECIFIC PROMOTION TERMS

特别活动条款

4.1. The amount of the cash bonus is based on the total net deposit of the client in accordance with the table below ("**Total Net Deposit**") made by the client in FXTM Wallet and the Trading Account in accordance with Clause 3.1 above after the Acceptance of these Terms during the Promotion Period (the "**Cash bonus**")

4.2. Total Net Deposit during Promotion Period is the difference between the total deposit and total withdraws during the Promotion Period in accordance with Clause 1.2 above.

活动期总净入金指的是您在根据以上条款1.2规定的活动期间的总入金和总出金之间的差值。

4.3. Each client can receive up to USD 2000 cash bonus.

每一位客户可获得最高2000美元的赠金。



4.4. To be qualified for this promotion, clients need to meet the minimum trade requirement in accordance with Clause 4.1 above before 28<sup>th</sup> February 2022. Eligible trade is applicable to all CFDs and shares. One trade refers to a complete round trip of opening and closing a position. Only positions opened and closed for more than 5 minutes are considered eligible.

为符合享受本次活动的资格,客户需要在2022年2月28日之前满足以上条款4.1所规定的交易量要求。合资格的交易适用于所有 CFD及股票。一手合资格交易指开仓、平仓一个来回的完整交易。只有开仓和平仓且开仓时间超过 5 分钟的交易才会被计入交易手数。

4.5. Clients who have had withdrawals before 28<sup>th</sup> February 2022 will be disqualified from for receiving the cash bonus of this promotion.

客户如果在2022年2月28日(含)之前有任何出金行为,则会被取消获得本次活动赠金的资格。

4.6. FXTM reserves the right to determine or change the amount of the cash bonus to issue to the clients at any point without prior notice.

富拓有权在无需提前通知的情况下在任何时间决定或修改赠予客户的赠金数额。

4.7. The cash bonus is available after the net deposit requirement is met in accordance with the amount of the Total Net Deposit during Promotion Period as defined in clause 4.1 herein.

客户在根据以上条款4.1中所规定的活动期总净入金金额达到入金要求后可获得赠金。

4.8. FXTM will review eligible clients on March 1, 2022.

Regarding to cash bonus, FXTM will issue cash bonus into the clients' MyFXTM USD wallet before March 31, 2022.

富拓将于2022年3月1日对已经合资格客户进行审核。

关于赠金, 富拓将在3月31日前注入客户的MyFXTM 内的美元钱包。

- 4.9. The eligible clients shall receive the cash bonus from the FXTM on USD wallet in MyFXTM that could be transferred on client's trading account. And the Cash bonus shall be available for trading or withdrawal purposes. 客户将从 FXTM 富拓获得赠金,并存入 MyFXTM 内的美元钱包,可转账至该客户的交易账户。此赠金可用于交易或提取。
- 4.10. FXTM shall not be liable for any margin call or losses that the client may suffer, including but not limited to losses due to stop-out level, as a reason of or during this Promotion Period.

根据本条款和条件, FXTM富拓将对客户可能由于本次活动或在本次活动期间所遭受的追加



保证金或损失,包括但不限于因强制平仓造成的损失不承担责任。

4.11. FXTM has the right to withdraw without prior notice the cash bonus gained if:

若出现下列情况,FXTM富拓有权撤销赠金,无需提前通知:

a) a breach of these Terms occurs;

违反本条款和条件;

b) FXTM has reasonably grounds to believe a misuse of the Promotion;

FXTM富拓有合理的理由相信活动被滥用;

c) The Client acts in bad faith and/or abusively and/or fraudulently and/or in a manner that is not in line with this Promotion and applicable Terms.

客户不诚实和/或滥用和/或欺诈和/或以不符合本促销和适用条款的方式行事。

4.12. During the Promotion Period the client can NOT participate in any other applicable and unexpired promotions announced by FXTM.

在活动期内,客户不可以参加FXTM富拓举办的其他适用的、未过期的优惠活动。

5 MISCELLANEOUS

## 其他事项

5.1 FXTM reserves the right, as it in its sole discretion deems fit, to alter, amend, suspend, cancel, or terminate the Promotion. In the event of modifying the Terms, FXTM shall give such notice to the client as may be required by applicable legislation. Under no circumstances shall FXTM be liable for any consequences of any alteration, amendment, suspension, cancelation, or termination of the Promotion.

FXTM富拓保留在自由裁量认为适当的情况下变更、修正、中止、取消或终止本次活动的权利,富拓应根据适用法律的要求向客户发出通知。在任何情况下,富拓不对由于活动的更改、修正、中止、取消或终止造成的任何结果负有责任。

5.2 Any indication or suspicion of fraud, manipulation, cash-back or bonus or swap arbitrage, or other forms of deceitful or fraudulent activity in a client's Account or multiple account with FXTM or otherwise related or connected to the cash bonus shall nullify all transactions carried and/or profits or losses garnered therein.

操控、返现或奖金或互换套利或其他形式的欺骗或欺诈活动,所有已执行的交易和/或由此 产生的利润或亏损均无效。

5.3 FXTM reserves the right, at its sole discretion, to disqualify any individual that FXTM suspects misuses or attempts to misuse the cash bonus or breaches the present Terms and/or any of FXTM's operative agreements and to cancel all orders and annul all profits of such client. If FXTM, in its sole discretion, suspects any cash bonus arbitrage or any misuse or attempts to misuse the cash bonus, and the client has open positions, FXTM reserve the right to withdraw the cash bonus. In these circumstances, FXTM shall not be liable for any consequences of the cash bonus cancelation.

FXTM富拓保留,在其自由裁量情况下,取消滥用或试图滥用本赠金活动、违反本条款和/ 或FXTM富拓任何有效协议的客户参加活动的权利,取消此类客户所有定单和所有利润。如 果FXTM富拓怀疑客户有任何赠金套利或任何滥用或试图滥用赠金活动的行为且客户已建仓, FXTM富拓保留撤回赠金的权利。在这些情况下。FXTM富拓不负责由于赠金取消造成的任 何后果。

5.4 Notwithstanding the Chinese language of this document, the English wording shall be the binding version in the event of any discrepancy between the two languages.
