# SWITCH TO FXTM PROMOTION

## Terms and Conditions

1. The Switch to FXTM Bonus Promotion (the "Promotion") is applicable to approved clients who meet the following requirements:
  - The Client was a client of any other forex broker and provides satisfactory evidence to prove the same.
  - The Client deposits an amount equal or in excess of \$200<sup>1</sup> (hereinafter referred to as the "**Minimum Deposit**").
  - The Minimum Deposit is made between the 01<sup>st</sup> November 2016 until the 28<sup>th</sup> February 2017 (hereinafter referred to as the "**Bonus Period**") or made within such other extended or reduced period that the Company may, in its sole discretion, give notice to the client.  
Transfers between accounts are not considered as initial deposits.
  - The Client accepts the present Terms and Conditions of the Promotion and the Operative Agreements prior to making the deposit.
2. The Bonus is calculated on Minimum Deposits made by one client in one account within a period of 30 days during the Bonus Period, starting on the first day the Minimum Deposit is made.
3. The Client shall be eligible to receive a 200% Rebate Bonus on the amount of each Minimum Deposit made in one account, up to a maximum of \$10,000 (hereinafter referred to as the "**Maximum Bonus**").
4. The maximum eligible Bonus shall be deposited in a virtual wallet visible to the Client through MyFXTM, within twenty-four (24) hours after the Minimum Deposit has been made.
5. The client shall receive credit of \$4, up to the maximum bonus, per full completed lot within the Lots Calculation Period (Monday 00.01-Friday 24.00\*), subject to the Client providing within the Lots Calculation period all necessary evidence to satisfy the conditions specified herein. The total credit amount per Lots Calculation Period shall be transferred and credited to the Client's account at the end of the Lots Calculation Period, the following Monday at 10.00\*.
 

**Example:** Mr. FXTM Client deposited \$300 USD on the 3<sup>rd</sup> November 2016, after having successfully registered as a Client, agreed to the Terms & Conditions of the Promotion and provided evidence of previously being the client of another broker. Consequently, Mr. FXTM Client is eligible to receive a maximum bonus of \$600 USD, calculated as the 200% of his deposit of \$300 USD. Mr. FXTM Client traded 25 lots during the first Calculation Period, and will thus receive \$100 USD as Bonus in his trading account the following Monday (calculated as follows : \$4 USD multiplied by 25 lots traded). Mr. FXTM Client shall continue to receive \$4 USD for every lot traded during the 30 days following the 3<sup>rd</sup> November 2016 (deposit day).
6. In the event where the Client fails to provide within the Lots Calculation period satisfactory evidence to prove that he/she was a client of another forex broker:
  - a) the credit accrued shall be transferred for payment to the next Lots Calculation Period.
  - b) subject to the volume traded by the Client, the client shall receive credit of \$2, from the Bonus, per full completed lot within the Trading Period. The total credit amount shall be transferred and credited to the Client's account at the end of the Trading Period, the following Monday at 10.00\*.
7. The Bonus credited to the Client account shall be freely available for the Client's use, and the Client shall have the right to withdraw the Rebate Bonus as soon as this is credited to his account following standard procedure.
8. Only positions that were open for more than 5 minutes will be eligible for the calculation of this payment.
9. Irrespective of the number of trading accounts that may be opened by a client with FXTM, the Promotion is applicable for only one trading account opened by each client and into which such client's first Minimum Deposit is made within the Bonus Period.
10. The Client shall not be eligible for further Rebate Bonus if he withdraws any sum during the Bonus Period.
11. Clients who are participating in bonus or other promotions of FXTM during the Bonus Period are not eligible for the Bonus.
12. Clients introduced to FXTM by Introducing Partners (Introducers) of FXTM Partners cannot participate in this Promotion.
13. The Bonus is applicable to all CFDs (excluding CFDs on shares), precious metals and commodity futures only and applicable to MT4 Standard, MT4 ECN, ECN Zero and Strategy Account.
