1. INTRODUCTION

引言

1.1. FXTM¹ is running the 2022 FXTM TRADER APP Promotion (the "**Promotion**") which is applicable to selected clients at FXTM's discretion, including clients assigned under IB & Affiliates. By participating in this Promotion, you agree to be bound by the Terms and Conditions herein (hereinafter referred to as the "**Terms**") as these are set out below.

1.2. This Promotion shall run from 14th October 2022 (00:01) to the 31st December 2022 (23:59) (Beijing time) inclusive (the "**Promotion Period**").

1.3. A client who participates in this Promotion shall receive the "**Cash Bonus**" as defined in accordance with clause 4 of this Promotion and subject to the Terms herein.

2. ELIGIBLE CRITERIA

- **2.1.** To participate in this Promotion, you must meet the following requirements: 為參加本次活動, 您須滿足以下條件:
 - a) You are a new or existing client of FXTM, deposited during the Promotion Period, or dormant client of FXTM, eligible to trade in accordance with, and have agreed to, the operative agreements;

b) All existing clients automatically qualify to participate in the Promotion from Launch. New clients qualify to participate in the Promotion from the date an Account is opened. A client's ownership of an Account with FXTM shall be deemed as the client's acceptance of the Terms.

c) Run a live trading account with FXTM as per the applicable deposit and/or other requirements of FXTM^2

d) Read and accept the Terms of this Promotion;

e) Make a deposit in the Account during the Promotion Period, following c) and d) above.

2.2 The Promotion shall only be available to each client at the discretion of FXTM to offer the Cash Bonus and shall be given to the client after receipt of the client's Acceptance of these Terms.

3 TRADING TERMS

交易條款

3.1 The Promotion is applicable to selected account types (Advantage and Advantage Plus).

本活動適用於特定帳戶類型(超低點差帳戶及0佣金帳戶)。

3.2 Irrespective of the number of trading accounts that may be opened by a new and approved client with FXTM, the Benefit shall only be applicable to the client's trading account approved by FXTM (the "**Account**").

不論FXTM富拓的新老客戶開設了多少個交易帳戶,本活動僅適用於獲得富拓批准的客戶交易 帳戶(以下簡稱"**帳戶**")。

3.3 Irrespective of the number of trading accounts that may be opened by a new and approved client with FXTM, only the Trading Volume (lots) completed under the FXTM trading account with the highest deposit amount will be considered as eligible Trading Volume (lots) for this Promotion. Therefore, the clients must complete the Trading Requirements in accordance with Clause 4.1 below in the FXTM trading account with the highest deposit amount.

不論FXTM富拓的新老客戶開設了多少個交易帳戶,在審核客戶是否完成本條款4.1規定的本 次活動的交易量(手數)要求時,將僅針對客戶入金金額最高的FXTM富拓交易帳戶下的交易 量(手數)進行審核,因此,客戶需確保在入金金額最高的FXTM富拓交易帳戶中完成本條款 4.1規定的此次活動所要求的交易量(手數)。

4 SPECIFIC PROMOTION TERMS

特別活動條款

4.1. To be qualified for this Promotion and receive the Cash Bonus in accordance with clause 4.2, the clients must complete the clients' first deposit in the FXTM Trader APP during the Promotion Period, no deposits amount is required.

為享受本次活動的資格,客戶需在活動期間成功於FXTM富拓APP完成首次入金,入金金額 不限。

4.2. The clients can receive USD \$20 Cash Bonus if the clients placed an order in a FXTM live trading account on the FXTM Trader APP during the Promotion Period.

客戶於活動期間在FXTM富拓APP中使用FXTM富拓真實交易帳戶下單一次,即可獲得價值 20 美元的獎金回贈。

4.3. Each client is only eligible to receive the \$20 Cash Bonus once during the Promotion Period. Clients who have been eligible to receive the \$20 Cash Bonus from the September Trader App Promotion are not eligible to participate in this Promotion and cannot receive the Cash Bonus.

4.4. FXTM reserves the right to determine or change the amount of the Cash Bonus to issue to the clients at any point without prior notice.

4.5. FXTM will review eligible clients by the end of every month. Regarding the Cash Bonus, FXTM will deposit the USD \$20 Cash Bonus into eligible clients' MyFXTM USD wallet within 20 working days after the eligibility is fulfilled.

4.6. FXTM shall not be liable for any margin call or losses that the client may suffer, including but not limited to losses due to stop-out level, as a reason of or during this Promotion Period.

4.7. FXTM has the right to withdraw qualification without prior notice if:

a) a breach of these Terms occurs;

b) FXTM has reasonably grounds to believe a misuse of the Promotion;

c) The Client acts in bad faith and/or abusively and/or fraudulently and/or in a manner that is not in line with this Promotion and applicable Terms.

4.8. During the Promotion Period the client can participate in any other applicable and unexpired promotions announced by FXTM.

5 MISCELLANEOUS

其他事項

5.1 FXTM reserves the right, as it in its sole discretion deems fit, to alter, amend, suspend, cancel, or terminate the Promotion. In the event of modifying the Terms, FXTM shall give such notice to the client as may be required by applicable legislation. Under no circumstances shall FXTM be liable for any consequences of any alteration, amendment, suspension, cancelation, or termination of the Promotion.

5.2 Any indication or suspicion of fraud, manipulation, cash-back or bonus or swap arbitrage, or other forms of deceitful or fraudulent activity in a client's Account or multiple account with FXTM or otherwise related or connected to the Cash Bonus shall nullify all transactions carried and/or profits or losses garnered therein.

5.3 FXTM reserves the right, at its sole discretion, to disqualify any individual that FXTM suspects misuses or attempts to misuse the Cash Bonus or breaches the present Terms and/or any of FXTM's operative agreements and to cancel all orders and annul all profits of such client. If FXTM, in its sole discretion, suspects any Cash Bonus arbitrage or any misuse or attempts to misuse the Cash Bonus, and the client has open positions, FXTM reserve the right to withdraw the Cash Bonus. In these circumstances, FXTM shall not be liable for any consequences of the Cash Bonus cancelation.
